Rulemaking Overview

- The purpose of this rulemaking is to provide federal alignment and administrative updates to Title 20, CCR sections 1601-1609.
- This rulemaking is not proposing any new efficiency standards for appliances, nor increases in stringency for existing standards



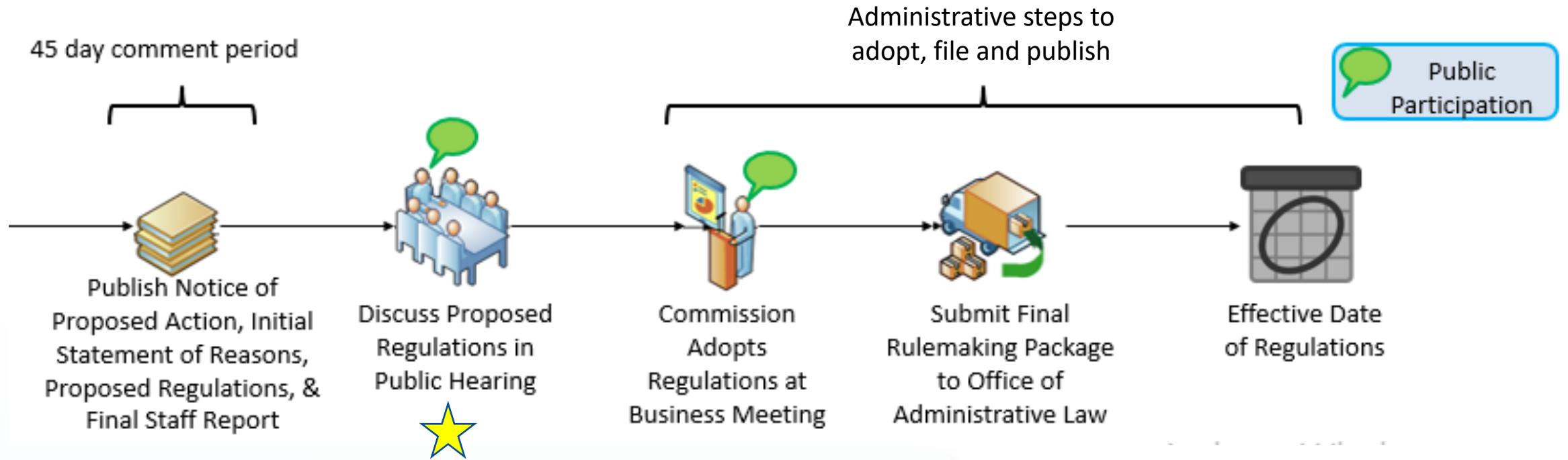


Proposed changes

- Updates to align with current federal law
- Updates to data submittal requirements and processes
- Removal of a redundant aspect of the marking requirement for commercial and industrial fans and blowers
- Updates and streamlining to CEC's product compliance review, enforcement, and administrative proceedings
- Other administrative and non-substantive changes for clarity and consistency
