Description: Ukraine notifies the adoption of the Resolution of the Cabinet of Ministers of Ukraine No 844 "On Approval of the Technical Regulation on Ecodesign Requirements for Electric Motors and Variable Speed Drives" of 23 July 2024.

The Resolution was published on 26 July 2024 and will enter into force six months from the date of termination or cancellation of martial law in Ukraine.

It is established that placement on the market and operation of electric motors and variable speed drives that meet the requirements of the Technical Regulation on Ecodesign Requirements for Electric Motors, approved by the Resolution of the Cabinet of Ministers of Ukraine No. 157 of 27 February 2019, and which were put into circulation before the date of entry into force of the Resolution No 844 of 23 July 2024, may not be prohibited or restricted due to non-compliance of such products with the requirements of the Technical Regulation approved by this Resolution.
