Description: In light of the United States Court of Appeals for the Fifth Circuit granting a petition for review of a [final rule](#) published by the U.S. Department of Energy ("DOE") on 19 January 2022 (notified as [G/TBT/N/USA/1762/Add.1](#)), and remanding the matter to DOE for further proceedings, DOE has considered the factors outlined by the Fifth Circuit on whether "short-cycle" product classes for dishwashers, residential clothes washers, and consumer clothes dryers are warranted under the Energy Policy and Conservation Act and confirms the withdrawal of "short-cycle" product classes in the 19 January 2022, final rule.
