Description of content:</b> The draft notification prescribes motorcycles, electric motorcycles and electric bicycles as label-controlled products.<br>This draft notification applies to the following products:<br>1. Motorcycles, which means a motorcycle powered by an engine and shall include a bicycle equipped with an engine.<br>2. Electronic motorcycles, which means a motorcycle that is propelled by electricity.<br>3. Electric bicycles, which means a bicycle propelled by the rider's power in conjunction with electricity, or propelled by electricity.<br>The label of label-controlled products shall specify the text, pictures, artificial designs, or image as appropriate which shall not cause misunderstandings about the essence of the products and shall be displayed clearly visible and legible in Thai language or a foreign language accompanied by Thai language. |
