- **Title, number of pages and language(s) of the notified document:** Draft Order of the Ministry of Communities and Territories Development of Ukraine "On Approval of the Technical Regulation for Energy Labeling of Refrigerating Appliances with a Direct Sales Function"; (46 page(s), in Ukrainian)
- **Description of content:** The draft Order proposes to approve the Technical Regulation on energy labeling of refrigerating appliances with a direct sales function, which will provide consumers with information on the level of efficiency of energy consumption by energy-consuming products, as well as additional information that will enable consumers to choose the most energy-efficient products.

This Technical Regulation establishes requirements for energy labeling and additional information on refrigerating appliances with a direct sales function, including appliances sold for cooling goods other than food.

The Technical Regulation has been developed on the basis of Commission Delegated Regulation (EU) No 2019/2018 of 11 March 2019 supplementing Regulation (EU) No 2017/1369 of the European Parliament and of the Council with regard to the energy labelling of refrigerating appliances with a direct sales function.
