Description of content: The draft Ministerial Regulation mandates rubber and plastics hoses, tubing for use with propane and butane and their mixtures in the vapour phase to conform to the Thai Industrial Standard TIS 895-2567 (2024) Rubber and Plastics Hoses, Tubing for Use with Propane and Butane and Their Mixtures in the Vapour Phase.
